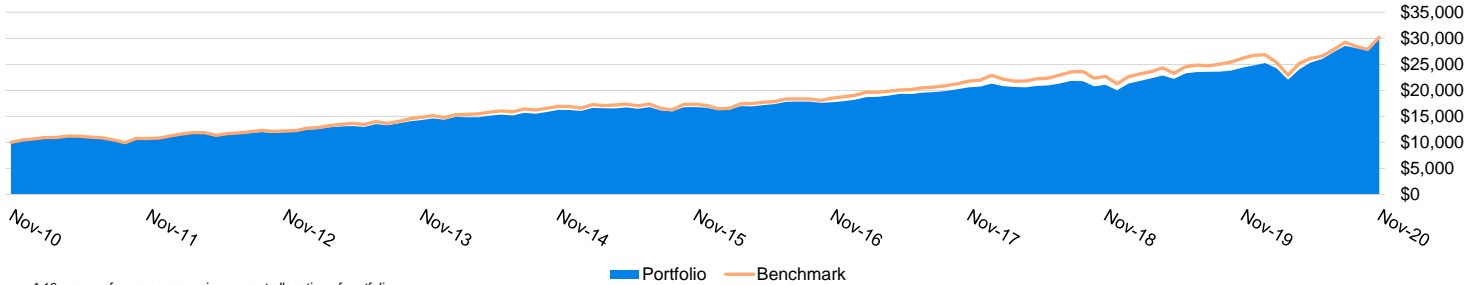

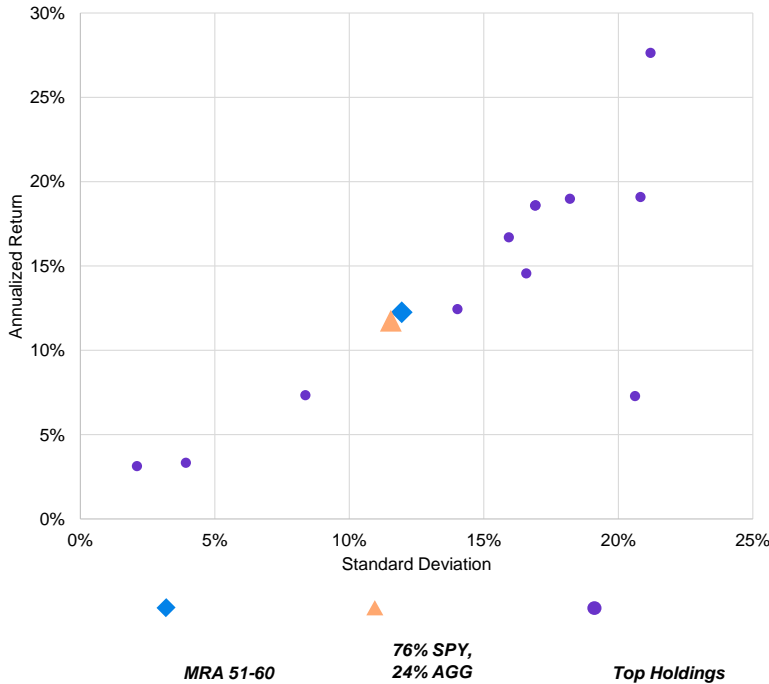

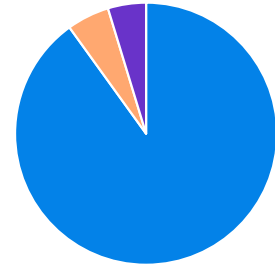

Risk vs Return (5Y)



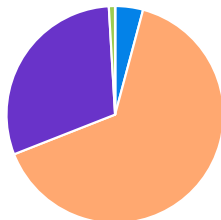

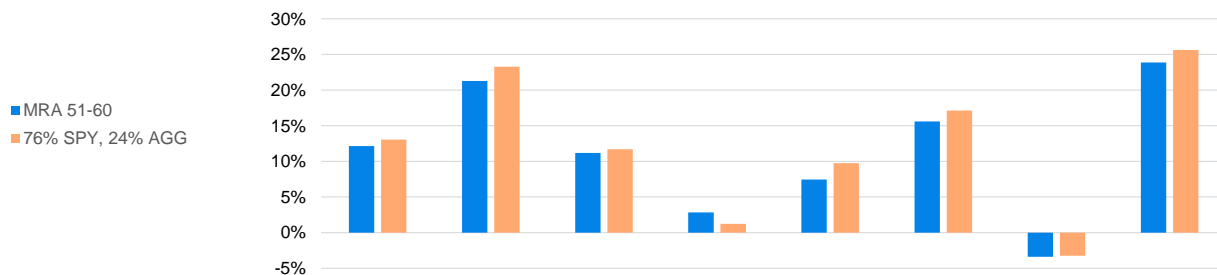

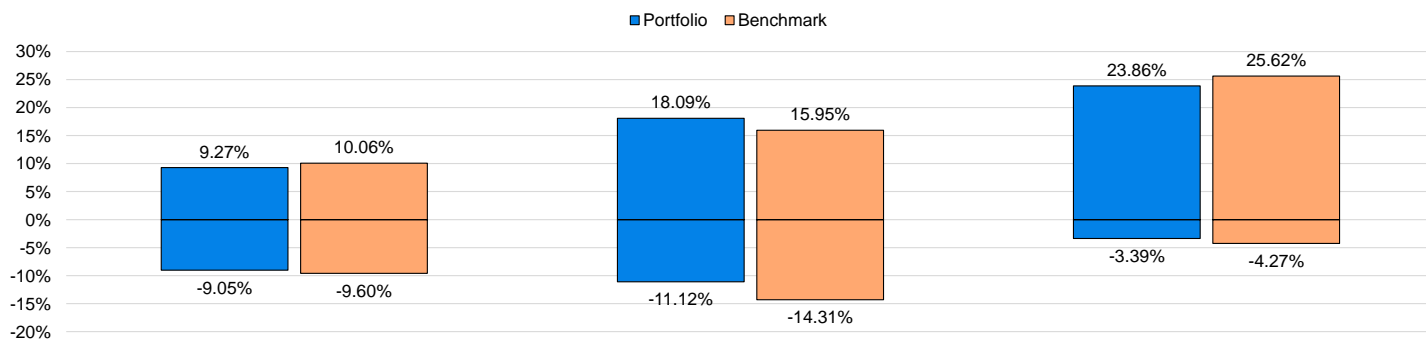
