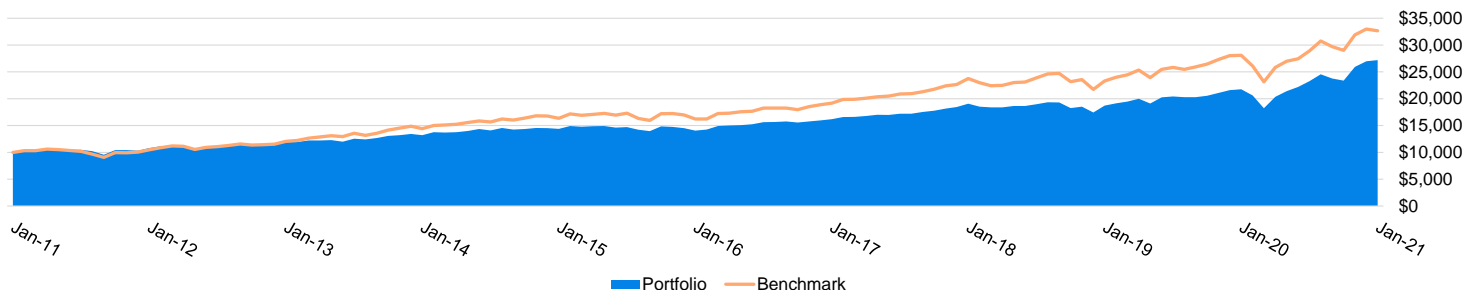

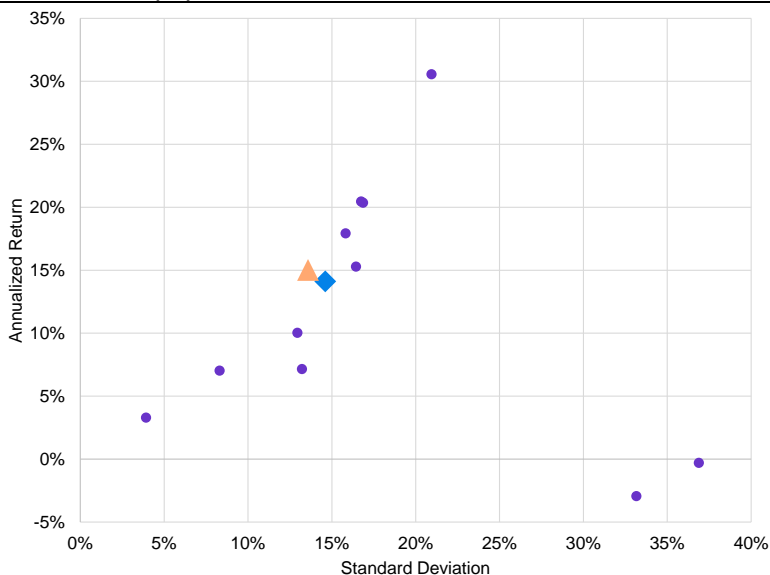
### Growth of \$10K

#### Risk vs Return (5Y)

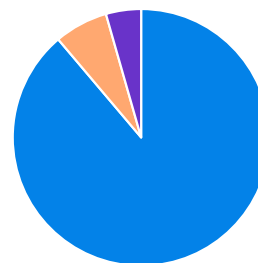

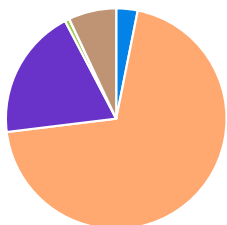

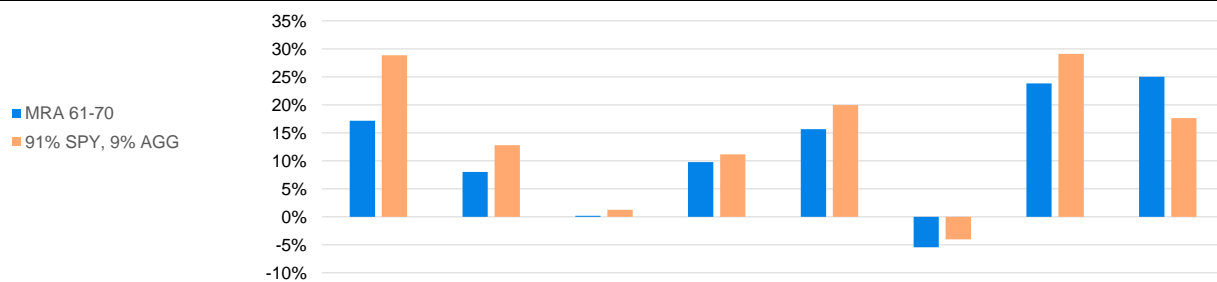

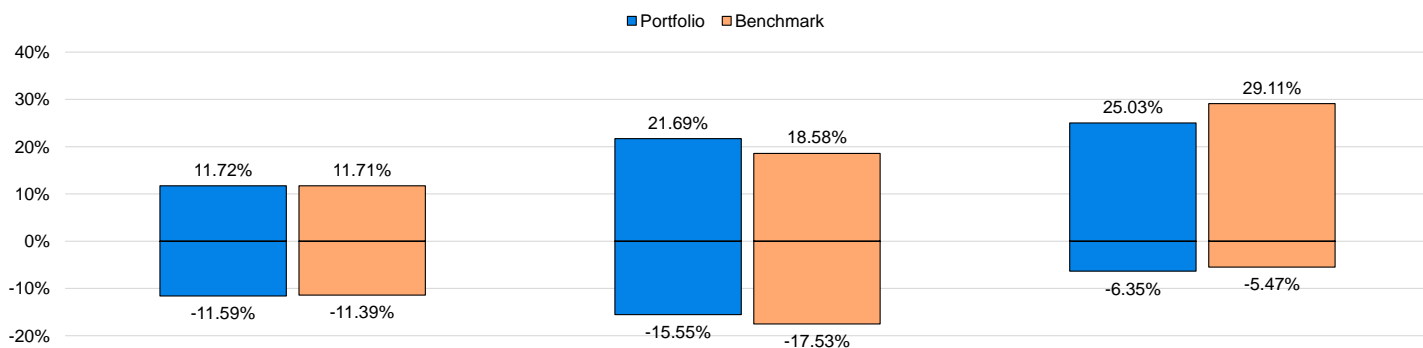
